This is what the SA Foundation looks for when people contact us to duplicate our program model: Commitment. Are they ready to stick to their passion and do everything it takes to see women freed from the bondage of sex slavery?

We are so glad to let you know that we are working with 2 more dedicated groups of individuals who have committed themselves: The team in Ontario, Canada was screened, assessed and trained by our leadership team and they have begun offering the day program part-time while they search for a front-line house and our team in Atlanta is heading up to Vancouver early in 2018 for their assessment, and training. The Atlanta program has had land and buildings outside of the city donated and are aiming for a start-up date shortly thereafter.

The Stuttgart, Germany team has not been slowed down by a lack of housing for their house and day program. They are fundraising with the hope of purchasing a place. They continue to network and refer women to our other German projects.

Our other leadership teams continued to be mentored as they opened their doors for their first year of service. These locations were:

- Berlin, Germany
- Karlsruhe, Germany
- Sophia, Bulgaria
- Athens, Greece

They each had an amazing first year; they learned a ton and several are at the point of needing Phase II programming for women who are completing Phase I!

Our other projects in Kathmandu, Nepal, Budapest, Hungary, Vancouver, Canada ran excellent programs and more than 35 women and their children received services through their programs last year. The Vancouver program opened their second house and expanded their job training programs, which secures the women for an extended period of time while they transition back into the community.

ONORS

"D" is for donors, but we think of you as much more than that! Yes, you give your funds to support our programs and activities, and for this we are so very thankful! But we see it as a partnership much more than a donor-donee relationship.

A large majority of those who partner with us have been with us for many years. They have seen how we have grown and how God has spread the seeds of recovery to many cities internationally. They have cheered and supported us as we learned how to disseminate the program and as we've needed additional funds to start-up new programs. Mere words cannot convey the depth of our gratitude! For those who are new partners, we hope that our relationship will continue to develop and deepen and we sincerely appreciate your trust in us to meet the recovery needs of these young women and their children.

VERYONE

This is a cause that everyone should be concerned about. There used to be a time when the only girls who ended up in sexual exploitation were runaways and girls from bad homes. While this group is still over-represented in this issue, we have seen so many situations where young girls, at tender ages, are tricked and coerced into the trade. Parents are rendered

almost powerless to find their children and get them out. So it is not just the girl from the 'wrong side of the tracks' that we need to worry about anymore. We need to watch our kids, educate them and support SA programs internationally that are helping them get out of these horrific situations.

Did you know that this year alone, the SA Foundation's leadership team and staff educated at least 2,000 people about this cause, locally, nationally and internationally? Education is at the heart of all our initiatives and fundraisers as the more people that come to understand this issue, the better chance we have of stopping it!

AITH/FUNDRAISING

Why does "F" represent Faith and Fundraising? Well, without faith in God's goodness and provision, we wouldn't be where we are today. However, at the SA Foundation Faith encompasses more than just fundraising - it is at the core of all that we do and who we are as an organization. Our programs are centered on belief in God's redemptive power and our

leadership are chosen because of their deep commitment. Our core values are focused on living out Christian principles and our fundraising activities encompass practices that reflect these principles.

LOBAL WONDERS

Global Wonders continues to meet its 3 main objectives:

- To provide training and employment to young women in both our Nepal and our Vancouver programs
- To provide education to the general public on the causes, effects and recovery of sexual exploitation and trafficking through home/work/school/church presentations and sales
- 3. To provide revenue to the Nepali program to offset fundraising efforts

This is the central aspect of all our programming: providing curriculum and programs that will assist our young women to achieve healing from their trauma. It is not enough to provide housing and employment. Without the tools to address their deep wounds, they will fail. At the SA Foundation, we understand that this will take time, patience, love and support.

STOP TRAFFICK

This campaign was developed to provide supporters with an easy way to bring awareness to their friends and family about the fight against human trafficking. There are currently 2 charity runs being held in Calgary and Vancouver called "I Stop Traffick Runs" that are held to raise funds for the cause. USTICE

Justice. It is not a word that our young women are familiar with. There has been a distinct lack of it in their lives thus far. They often have had no one stand up for them, protect them, or provide them with any justice for the things they have been forced to endure. This is where healing needs to take place and our specially designed program curriculum encourages the women to bring the injustices out into the light, to grieve over them and to give them over to God for justice, as He sees fit. Only then will true peace be able to reside in their hearts. Kids!!! We love them! Not many organizations are willing to take a mom who has a child or children because of the infrastructure that is needed to care for them. But at SAF, we see a bigger vision: If we help the mom to heal, then her children will not be the next generation of exploited people. To support this journey, the homes need to be set up to accommodate children and a specialized childcare centre must be in place so that the moms can attend day programming. We have such joy when we see these little ones thrive in an environment of community and love!

EGALIZE

IDS

In Canada, there continues to be a movement of well meaning, but misinformed people, who are advocating for the legalization of the sex trade. Their case studies are taken from women that have been entrenched in the trade for so many years, they can't imagine themselves free. They want protection and they want to guarantee safety, neither of which can come from an abuse of power. In countries that have gone this route, it is always the illegal side of the trade that flourishes and the demands of the buyers requires organized trafficking rings to meet the incredible quotas that are needed to satisfy misplaced hungers. Women working in legalized sectors receive little to no protection as this industry is about profit first. We must stand against this initiative and we must not let our young women grow up thinking it is okay to be bought and sold!

OTHERS

We have talked about the kids, but what about the moms? Over 70% of the women we serve are mothers!

What we have seen over the past 28+ years is that when they come to our program they often struggle with how to be good moms to their kids because they've never had a role model. They all want to parent differently (and better) than they were parented, but they are missing essential skills. This is where our amazing house mothers come into play. They walk alongside these young moms and offer advice and support. The young women have a very

hard thing to deal with – being in recovery full time and parenting a child or children on their own! It takes a lot of courage; however, they have great motivation: Their love for their child and their desire to build a good life for them is worth all the pain and sacrifice!

UALITY VS. QUANTITY

At the SA Foundation, we may never impress you with the numbers of women we take in each year. That is okay with us, because our programming is not meant to take in vast numbers of women per year. Our focus is on quality, individualized programming that meets the recovery needs of our young women. This cannot be accomplished with vast numbers of women at one time. However, over time as our reach expands to

new communities and new partner organizations adopt our model, the number of lives saved increase as well! What you can be assured of though, is that our programs offer top quality programming that meets the entire needs of our participants, for up to 7 years! This includes housing, recovery programming, life skills development, job training and educational preparation. Contact **Carla@ safoundation.com** if you believe you would like more information about our programming. **ESPONSIBLE** One of the things the leadership of our organization takes very seriously is our responsibility to our supporters. We believe that a non-profit is a business and should be run accordingly. We take accountability seriously and take every measure needed to ensure that funds are handled responsibly and are used for the purposes

intended. Our administration and fundraising costs combined consistently remain below 15% as we desire that the majority of your support go directly to the women needing help.

UCCESS

Our programs consistently generate at least 70% success rate, over a 3-year program period. This is very high for a population that has so many barriers to success. What does success in SAF mean?

It means that, after staying in our program for 3 years, we can expect that 70% of our program participants will:

- 1. Have learned basic living skills to enable them to live in the community at large
- 2. Remain drug and alcohol free
- 3. No longer accept sexually exploitive situations
- 4. Be equipped with job skills that will enable them to build a future for themselves and their children

The other 30% of women are often too entrenched in the world of sexual exploitation and are not yet ready for the depth of change required to rebuild. Our doors always remain open for them.

AKES TIME TO HEAL/TRAINING

We just had to talk about two topics here because they are so central to who we are and what our mission is!

Some people ask why our programs are so lengthy – does it really take 7 years to rehabilitate a woman? And our answer is yes, because it takes time to heal! Imagine that you've lived a lifetime of abuse, neglect and trauma. Imagine that you have very few lifeskills and very little education. Imagine that you've never had a real job and have nothing to put on your resume. How long do you think it would take you to be secure enough to move forward with your new life? At SAF, we know that this takes time, lots of it. Our program is designed to increase levels of independence at each phase of programming so that one day our women will be able to succeed on our side of the streets. It just takes time.

Next is training. Without real-life situations to participate in, it's hard to duplicate a model. Our frontline program in Vancouver doubles as our international Internship Centre for new leaders. We require that they come to Vancouver, live with the women, attend the day program and deliver classes, and receive specialized training on program delivery & management, financial management, operations, governance and mentorship. They leave with all the documentation and curriculum they will need to run an effective program for exploited & trafficked women in their city. 2. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations. The financial statements have, in management's opinion, been properly prepared using careful judgement with reasonable limits of materiality and within the framework of the significant accounting policies described below.

REVENUE RECOGNITION

The Foundation follows the restricted method of accounting for contributions. Contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

INCOME TAXES

The Foundation is a not for profit Foundation under the Income Tax Act and, therefore, is not subject to either Federal or Provincial income taxes.

CAPITAL ASSETS

Capital assets are recorded at cost. Amortization is provided at the following annual rates:

NOTES TO FINANCIAL STATEMENTS

MARCH 31, 2017

1. PURPOSE OF THE FOUNDATION

DEFINITIONS

"The S.A. Foundation" means The S.A. Foundation (Servants Anonymous) - Canada.

This "Population" means children, women and youth with or without children who are either sexually exploited/trafficked or who are at high risk of becoming victims of sexual exploitation/trafficking.

"The SA World Services Division (SAWS)" means an integral part of the SA Foundation's organizational structure created to facilitate the delivery of its programs and services, training, production and retailing charitable activities.

OBJECTS OF THE SA FOUNDATION

- a) To ethically raise funds in any way to fulfil the SA Foundation's objects and charitable activities and to use the SA Foundation's funds according to and in pursuit of its objects and charitable activities.
- b) To directly assist this "population" in their re-integration into society.
- c) To assist this "population" in their re-integration into society by co-operating with local organizations abroad.
- d) To assist this "population" in their re-integration into society by gifting organizations that are "qualified donees" as defined in subsection 149.1(1) of the Income Tax Act and that deliver programs and services to this "population".
- e) To provide qualified donees in Canada or through co-operating with local organizations abroad, with the needed assistance and training to give them the expertise to deliver necessary programs and services to this "population".
- f) To produce and retail through related business activities as defined under the Income Tax Act, SA religious publications, educational and marketing materials and items such as handicrafts as a means to achieve the SA Foundation's charitable programs.

2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

MARKETABLE SECURITUIES

Marketable securities are recorded at fair value based on published trading data. Realized and unrealized gains and losses are reported in the statement of operations.

CASH

Cash is a deposit with major financial institutions and is, therefore, not subject to significant credit risk.

FOREIGN CURRENCY TRANSLATION

Foreign currency denominated monetary assets and liabilities are translated into Canadian dollars at the exchange rate in effect as of the date of the balance sheet. Foreign currency denominated non-monetary assets and liabilities are translated into Canadian dollars at the exchange rate in effect on the transaction date. Revenue and expense items are translated at the average exchange rates for the period. Gains or losses in translation have been charged to income of the current period.

FINANCIAL INSTRUMENTS

Financial instruments included in these financial statements include cash, term deposits, marketable securities, accounts payable and accrued liabilities.

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in revenue. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.
